Mohamed Sadiq informed that the research scholars from the department of biochemistry and microbiology are getting approval for the research projects involving animal studies, from the IAEC, Committee for Control and Supervision of Experiments on Animals (CCSEA), Department of Animal Husbandry and Dairying, Ministry of Fisheries, Animal Husbandry and Dairying, Government of India.
